County Councillor Report:

"Fibre Optic update

I organised a meeting with a representative from Gigaclear to find out about fibre optic provision being made in the Tewkesbury County Division. Here is the information relevant to the Twyning area from my meeting. The Government have pledged via a public subsidy, to include fibre optic across the UK under the Project Gigabit scheme. This is in order to get 80% of UK properties covered by Gigabit - capable Fibre by 2025. This replaces Superfast which was to provide between 30-80Mbps across the UK. Fastershire's aim is to try to reach areas that would not be covered by a commercial investment or an upgrade, such as rural or harder to reach areas which often also include areas of deprivation. Superfast broadband is different to fibre optic. Superfast has a fibre connection to a local distribution cabinet and then uses traditional copper from the cabinet to the property. Fibre connecting to the cabinet cannot be reused or repurposed to connect full fibre so Gigabit (1000 Mbps and upwards) has to be provided as a separate, new network to one already in place, you can't simply replace the copper with fibre. As Twyning and Twyning Green are already covered by Superfast via BT, there are no current plans for Gigaclear to extend here. Superfast means that the area should be within the 30-80 Mbps Download, (anything above 30Mbps is classed as Superfast). The village will have benefitted from public subsidy under the superfast scheme or as a commercial build by BT Openreach. Instead, residents need to contact their broadband providers directly and ask them. There is however full fibre in a nearby area covering Church End and its surroundings. This is for Full Fibre under the Gigaclear contracts as these areas were not included under the BT

Openreach Superfast schemes. New developments typically have Superfast and sometimes even Gigabit Fibre. Modern developments usually have planning regulations that mean they have ducting installed for telecommunications as part of the build. Older developments will sometimes have ducting, but this can often be 'direct bury of cable' therefore it is impossible to reuse or use overhead poles. Typically Developers have their own arrangements with ISPs (Internet Service Providers) and Network Providers. Tewkesbury (including Twyning) has 98.4% domestic properties covered at at least 30 mega bits per second and 26.5% have fibre optic. Residents can check their own broadband / fibre by putting their postcode into: www.thinkbroadband.com or by asking the provider they currently use. www.fastershire.com has an address checker

Consultation has begun on the Fire and Rescue Service's Community Risk Management Plan (CRMP) 2022-2025, which takes place over an eight-week period ending on 26th November 2021. The CRMP is an assessment of risks and how effectively resources are used to address those risks. All fire and rescue services have to produce a CRMP every three years as a minimum. New Car Parking machines have been installed in all the Borough Car Parks. Where possible they are solar powered and payment can be made either by card, mobile phone or cash.

You can now recycle small electrical items on the usual bin days. Basically this applies to electricals that have either a plug, battery or cable and about 75% of these items can be recycled so a good facility for us all to use.

The National Lottery Community Fund has grants available for climate change ideas from local groups. Amounts available are between £1000 and £10,000. Any bids need to be in by 18th November 2021.

The high court hearing regarding the proposed bridge at Northway is to due to take place on the 21st Oct.

Committee determination for the land at Nut Orchard has been delayed pending some outstanding landscape reports.

You will have heard the application at Fleet/Downfield Lane is going to appeal but the developers have also put in another planing application virtually the same as before. This is very unusual set of circumstances and the reasons for this are unclear. Residents should be encouraged however to submit their comments again as it is a new application and previous comments don't count.

Planning Development Manager, Paul Skelton, has tendered his resignation and will leave the Borough at the end of the year after 22 years service.

The developers for the Mythe application for 235 houses will be doing a presentation at Tewkesbury Town Hall this Wednesday at 6 pm.
