256. Planning Consultations

21/01372/FUL Replacement of an existing conservatory with a single storey rear extension. Shooters Moon, Goodiers Lane, Twyning – **No objection**

21/01349/FUL Erection of timber framed outbuilding (retrospective application). 13 Lynworth Lane, Twyning, Tewkesbury – **No objection**

21/01395/TPO Holm Oak (T1 of TPO 303) – Puckrup Hall -Remove the dead wood from the canopy at the earliest opportunity and that the remainder of the canopy is crown thinned by ten percent and crown reduced by 3-4m to further reduce the potential for wind and/or snowloading in extreme weather events. – **No objection** 21/01082/OUT Outline application for residential development for up to 47 units and associated works, with all matters reserved for future consideration except for access (Revised proposal further to refused application ref: 19/01084/OUT). Land At Fleet Lane – Economic Benefits Statement and Energy Statement – **Defer Comment** 21/01384/OUT Outline planning application for an extension to the Duddage Manor Business Park for commercial development including Classes E (office and light industrial), B2 (general industrial) and B8 (storage) and new access and associated infrastructure (all matters reserved for future consideration). Land West Of Duddage Business Park,

Brockeridge Road, Twyning – Currently 8-10 light industrials units with time restrictions on working hours. Proposal in excess of allowance in Local Plan and the density of the site does not fit in its rural setting.

Waste Local for Gloucestershire – consultation

Waste Local for Gloucestershire | Duty to Co-operate Scoping Paper - Consultation 2021

Gloucestershire County Council is preparing a new countywide Waste Local Plan. As part of this process it must comply with planning legislation covering co-operation with other organisations on strategic planning matters. This is known as the 'Duty to Co-operate'.

To help identify and respond effectively to strategic matters during plan-making, the County Council has prepared a draft Duty to Co-operate Scoping Paper. A consultation is now underway looking at what strategic matters need to discussed; which organisations need to be involved; and how future collaborations might be carried out and recorded.

The County Council has invited views from a wide range of organisations and others likely to have an interest in waste planning across the county over the coming years. The consultation is due to end at 5pm on Tuesday 21st December 2021.
