	Apologies received from the Clerk.
960	To receive declarations of interest/requests for dispensation
	There were no declarations of interest or requests
961	Proposed Development Consultation-Cherry Orchard Lane Alban Henderson gave a presentation explaining the proposed development on behalf of the landowner. There is no developer involved at present. The plan shows entry to the site on Shuthonger Lane but the correct name is Church End Lane. The plan shows how 70 houses can be fitted on the site to obtain outline planning permission but the layout may vary. A very limited number of leaflets have been distributed to residents close to the site and 3 responses have been received. Councillor Hadley pointed out that a development of this size would require the provision of a footpath on Church End Lane. Mr Henderson said that a proposed development on the other side of Church End Lane will be providing a footpath but a crossing will be necessary. Several of those present expressed serious concern about adding 70 further houses to the village sewage system that is already running at full/over capacity with frequent outflows into the River Avon from the local sewage works. Concerns were also raised that the local school would not be able to take the extra children living on the development and could result in children as young as 4 years old being bussed to schools in Tewkesbury. Mr Henderson was asked to pass on a request for his client to arrange a village meeting to discuss the proposal.
